In keeping with Orders and Regulations for Music Organizations in the Canada and Bermuda Territory (1999), The Legacy Chorus exists to proclaim the Army's message:*

Membership in the Chorus is open to adult musicians who meet one of the following criteria;

- Soldier or Adherent of The Salvation Army;
- Member of other Christian Churches and/or Denominations.

Membership of any member is subject to termination for;

1. Conduct that brings disrepute to the Chorus or The Salvation Army.
2. Failure to fulfill reasonable musical responsibilities to the Chorus to the best of one's abilities.
3. Conduct disruptive to or damaging to the spirit of the Chorus, or its operations.

Applicants must accept the terms of the Constitution and the Mission Statement of the Chorus as a condition of joining the Chorus. Your signature below indicates your acceptance of the terms and conditions set out above.

Any Chorus member acquiring other member's personal information in the normal course of Chorus operations and communications is equally bound by this policy as if they were a member of the Executive Board of Management of the Legacy Chorus.
